

# Motorhome parking

at the World Conference Center Bonn, Bonn-Gronau

## Terms of Use

The operator of the motorhome parking lot at the World Conference Center Bonn is Bonn Conference Center Management GmbH. By using the motorhome parking lot, the user of the parking facility—hereinafter referred to as the “user”—accepts the parking regulations posted at the entrance and these Terms of Use. Use of the parking facility is at the user’s own risk. The user is liable for all damage caused by the user, the user’s agents, or the user’s companions. The user is obligated to report any damage to Bonn Conference Center Management GmbH immediately. Furthermore, the user is liable for any contamination of the parking facility caused through negligence. Reserving areas, blocking access with objects, and excessive strain on the grounds—e.g., by trailers—are not permitted.

## Fee

The fee for motorhomes is valid for 24 hours and is listed on the price display at the pay station. The parking ticket must be displayed in plain view inside the vehicle at all times. The maximum stay is 3 days.

## Permitted Vehicles

This parking space is reserved exclusively for self-contained motorhomes. Travel trailers, trailer combinations, awnings, and tents are not permitted. Vehicles must be parked in a space-saving manner. Overnight stays outside the motorhome—for example, in tents—are prohibited. The parked motorhome must be securely locked and secured in accordance with standard traffic practices.

## Order in the motorhome parking area

Users must act considerately. Noise or disruptive behavior of any kind is prohibited. Quiet hours at the motorhome parking area, from 10:00 p.m. to 6:00 a.m., must be strictly observed. Engaging in any commercial activity on the area is prohibited. The use of drones is prohibited. Users must ensure at all times that they do not obstruct or endanger others.

## Dog Ownership

Dogs of all sizes must be kept on a leash at all times. Dog waste must be cleaned up immediately.

## Barbecues & Open Fires

Open fires and the use of charcoal grills are strictly prohibited.

## Disposal

Mobile restroom units are temporarily available for emptying toilet cassettes (black water). Graywater tanks can be emptied free of charge daily between 7 a.m. and 6 p.m. at the wastewater treatment plant located at Salierweg 7, 53117 Bonn. The area must be kept clean and free of any trash or debris. Violations will be reported to the authorities and will result in a ban from the premises.

## House Rules

In exercising its right to manage the premises, the operator is authorized to remove individuals from the area, prohibit their use of the site, and issue instructions on a case-by-case basis if this appears necessary to maintain safety and order at the motorhome site or in the interest of the area’s guests. The area is under video surveillance (see the posted notice for privacy information).

## Technical Malfunctions
